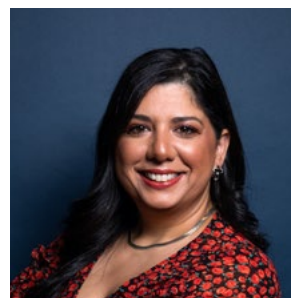

Nominations

DEADLINES	Exchange students must be nominated to the UCT GSB by the CEMS Programme Manager of their home university on the CEMS.org site. Following this, accepted students will be invited to complete a UCT application. 1 May: Nomination Deadline 1 July: Elective course registration for Term 1 30 November: Elective course registration for Term 2

Registration and Visa Process

Once nominated, we direct students to a link to apply online using the UCT GSB Exchange Application Portal. A place offer can be sent after the student completes the online application and submits the required documents. The system will automatically generate the students' UCT student number, student profile and the required letters for the study visa application.

The UCT GSB is prohibited from registering foreign students unless they are in possession of a valid visa for South Africa for the duration of their study period. It is every student's responsibility to ensure that they are in possession of a valid visa to enter South Africa before travelling.

We advise all students to contact their nearest South African Embassy or Consulate before travelling to South Africa, in order to confirm visa requirements.

Study Visas are required for all foreign students intending to study at a learning institution in South Africa for longer than three months. Students must apply for a South African Study Visa through their nearest South African Embassy, Consulate or Trade Mission, and should include a copy of the admissions letter offering them a place at the UCT GSB, together with a brief motivation of their reasons for wanting to study in South Africa.

Kindly note:

Certain documents take several weeks to obtain, for example, police clearances or FBI reports (for US students) could take up to 12 weeks to process.

Visa applications take a minimum of 8-10 weeks to process in the case of complete applications (all documentation in English) meeting all the requirements. Students should therefore ensure that they obtain the list of required documentation from their nearest SA foreign mission and start collecting their supporting information well in advance. Upon receipt of their UCT GSB Admissions Letter they should immediately submit their visa application for timeous processing.

Learning Environment

LANGUAGE OF INSTRUCTION:

English

CLASS FORMAT

Lectures, groupwork, discussions, case studies, and presentations.

ATTENDANCE

Class attendance is mandatory, except where permission is granted by the Academic Director.

PARTICIPATION

Active participation is encouraged and forms part of each student's grade, (5–10%). Much of the coursework is carried out in groups, preparing students for the challenges of managing and being part of a team. Skills such as team-building, communication, delegation, negotiation and conflict resolution are honed through group interaction.

ELECTIVE COURSES

Elective courses are offered each year, depending on student interests, and our offering changes from year to year. During Term 1, CEMS MIM students can participate in exclusive CEMS MIM elective courses.

During Term 2, students participate in special international student electives with students from the UCT GSB partner schools.

Elective courses have either a weighting of 5, 10 or 15 South African credits and usually consist of 16 two-hour lectures plus syndicate groupwork and individual preparation. The total workload per 5-credit Elective course is around 50 hours (including lecture contact sessions, syndicate group work and individual preparation).

Full elective course outlines will be made available via the student online platform in June and November.

Facilities

The UCT GSB's Breakwater Campus is situated in the heart of Cape Town's most popular tourist attraction, the Victoria and Alfred (V&A) Waterfront. Centrally located and easily accessed, the UCT GSB is just 1.5km away from the central business district and 20 minutes from Cape Town International Airport.

The campus is equipped with modern lecture theatres and syndicate rooms for group study, as well as a library and restaurants.

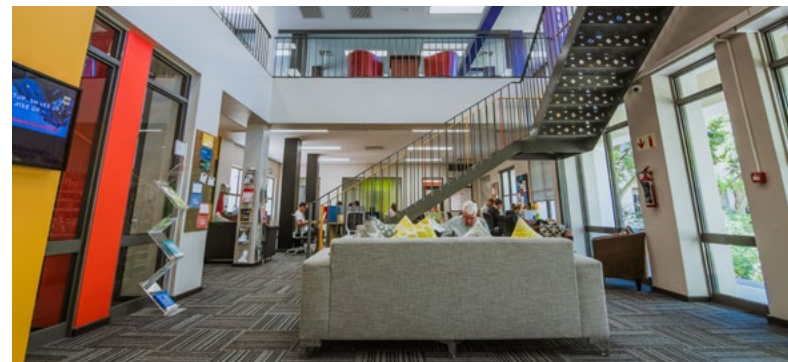
The Breakwater Campus, once a 19th century prison, offers library services, student work rooms, a new Solution Space environment specially designed to foster creativity and collaboration with floor-to-ceiling chalkboard walls, flexible furniture for multiple setups, hot-desk facilities, lounge areas, a computer lab (e-mail, internet and Wi-Fi), an open learning space including tele and video conferencing facilities for virtual meet-ups and presentations.

The Cape Town V&A Waterfront is a major tourist attraction on our doorstep and Cape Town's famous Table Mountain overlooks the School, the City and the Harbour. Students may make use of the University's sports facilities on the main campus, or private arrangements may be made with the Virgin Active Gym nearby. As an added benefit to studying at the UCT GSB, you'll be situated in one of the most beautiful cities in the world.

As we understand the importance of managing expectations, please note that the UCT GSB is situated in South Africa's premier tourist destination, which can lead to a shortage of student housing.

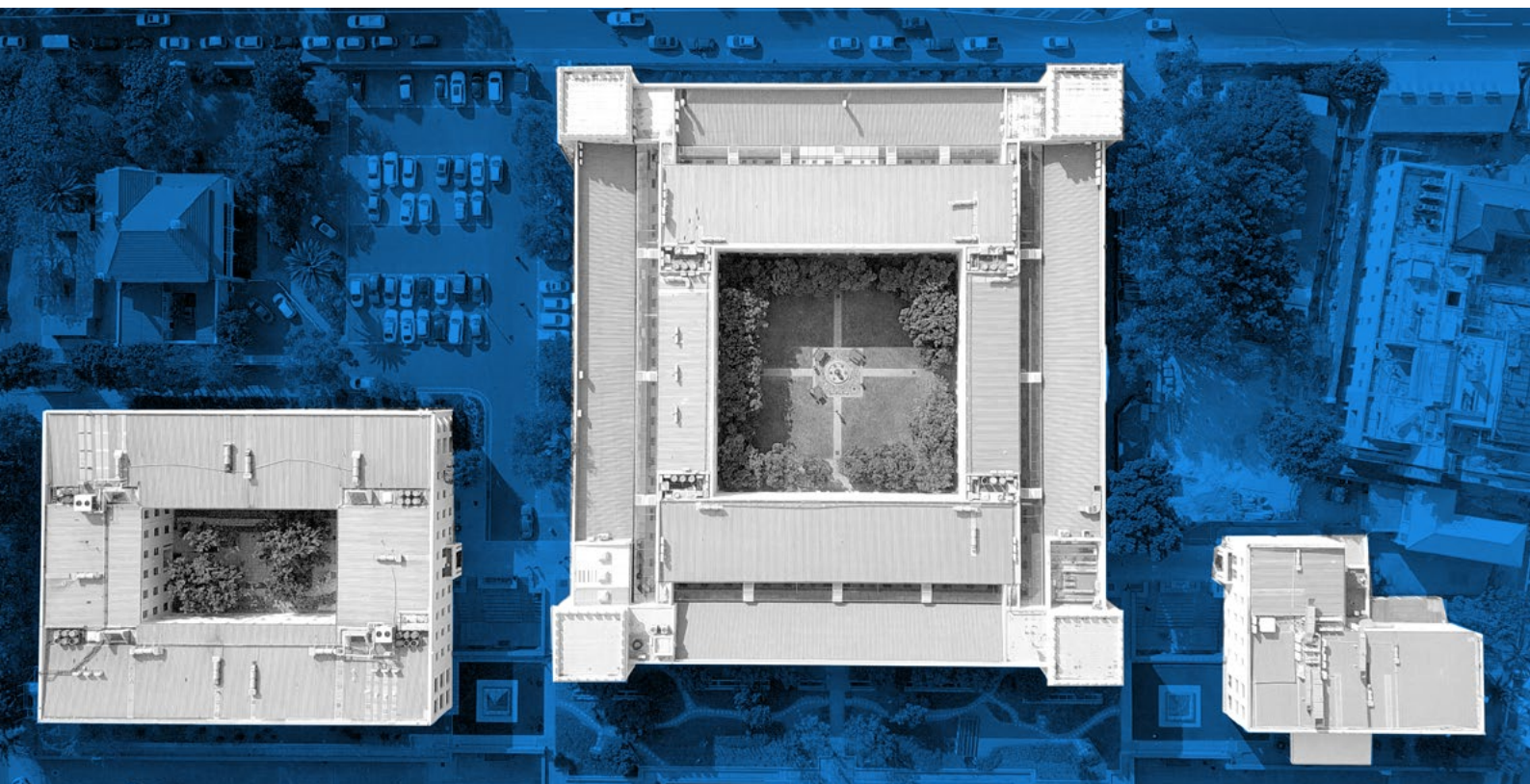
It's strongly recommended that students begin their search for accommodation early, as securing short-term rentals, especially for exchange students, can be challenging.

Cost of living in Cape Town

Cape Town is an affordable destination for many visitors from around the world, with the Rand offering a favourable exchange rate again or global currencies.

Below is a table of approximate costs of living in Cape Town. The exchange rate in the table below is calculated at R20 to the Euro. Please check the current exchange rate before you work out your own budget – and bear in mind that the South African Rand is subject to fairly wide exchange rate fluctuations. All amounts listed are estimates, and of course your expenses will depend largely on your lifestyle while in Cape Town – including whether you wish to travel around our beautiful country or to our neighbouring states, such as Namibia, Mozambique, Zimbabwe or Botswana or prefer to stay in South Africa.
